4.	License issuance fee for a reciprocal non-independent level (LBSW-R, LMSW-R, LAC-R, LSAT-R, LASAC-R, LAMFT-R)	\$ 100.00
5.	License issuance fee for regular independent level (LCSW, LPC, LISAC, LMFT)	\$ 250.00
6.	License issuance fee for a reciprocal independent level (LCSW-R, LPC-R, LMFT-R, LISAC-R)	\$ 250.00
7.	Temporary license	\$ 50.00
8.	Fingerprint background check	\$ 40.00
9.	Biennial renewal (first area of licensure) Each biennial renewal for additional disciplines if renewed at the same time	\$ 350.00 \$ 175.00 <sup>1</sup>

<sup>1</sup> The cost of an individual renewal is \$350. If an individual with multiple licenses renews the licenses at the same time, the first renewal is \$350. Each additional renewal is \$175 if renewed at the same time.

<sup>2</sup> All requests for written verifications must be in writing and include the \$20 fee for each license verification requested. Verbal verifications of an individual's license may be obtained by calling (602) 542-1864. Printed verifications can be done from the website.
