TEMPORARY LICENSE APPLICATION INSTRUCTIONS

I. Eligibility for a Temporary License

1. You must have already submitted an application for a regular license or a reciprocal license application to be eligible for a temporary license.
2. You must either:
 - A. Be currently licensed or certified by another state behavioral health regulatory entity

OR

 - B. Submit an application within 12 months of graduation from the education program submitted to meet licensure requirements and be approved for licensure pending passage of the required exam. You are not eligible under this section if you have previously taken the required exam.
3. You are not eligible for a temporary license if you are the subject of a pending complaint or if you have had a license or certificate to practice a health care profession suspended or revoked by another state regulatory entity.
4. If you have a criminal history or a history of disciplinary action by a state regulatory entity, you are not eligible for a temporary license without prior Board approval.

II. Practice Restrictions for Temporary Licenses

If your request for a temporary license is approved, you can only practice under direct supervision.

III. Fee

The temporary application fee of \$50 is NON-REFUNDABLE and must be in the form of a cashier's check, certified check or money order payable to the Arizona Board of Behavioral Health Examiners. Personal checks cannot be accepted.

IV. Additional Requirements and Restrictions for a Temporary License

The requirements and restrictions regarding temporary licenses are contained in A.A.C. R4-6-306. You can review this rule, as well all the Board's rules, on the Board's website at www.azbbhe.us.
