

ARIZONA BOARD OF BEHAVIORAL HEALTH EXAMINERS SUPERVISOR REGISTRY

The following registry displays licensees who have met the educational requirements to provide clinical supervision. Inclusion on the registry is voluntary, so not all supervisors eligible to provide clinical supervision will be listed. It is the supervisee's responsibility to verify the proposed clinical supervisor maintained their licensure throughout the period of supervision, and that the clinical supervision they receive meets the Board's requirements pursuant to A.A.C. R4-6-212. For clinical supervisors with a certification from a national accrediting body referenced in A.A.C. R4-6-214(A)(1)(b-d), it is the supervisor's responsibility to meet the ongoing requirements of the accrediting body to maintain the certification. If the national certification is revoked prior to its expiration, clinical supervision hours provided to supervisees after the revocation will not be accepted for licensure purposes.
