





1           4.     A 09/26/14 court ruling indicated the following:

2           a.     On 07/17/14, Respondent appeared regarding the criminal damage  
3           charge.

4           b.     "On that date, [Respondent] in the presence of the court, yelled  
5           profanities at the prosecutor, yelled that she was leaving, refused to obey  
6           the court's instruction to cease yelling, yelled profanities at the court, and  
7           in further disobedience of a direct court order, ran from the court room  
8           prior to being excused."

9           c.     The incident occurred in the presence of a crowded court docket.

10          d.     Respondent was summarily found in Direct Contempt of Court pursuant  
11          to Rule 33.2a for her behavior in the court room.

12          5.     During the Board's investigation into this matter, Board staff made multiple  
13          attempts to contact Respondent.

14          6.     On 04/28/16 when Respondent finally contacted Board staff, she indicated:

15          a.     She would not be participating in any further investigations by the Board.

16          b.     The Board is viewed poorly by the public because of actions like this.

17          c.     Respondent doesn't see why the Board is "dragging over such a small  
18          matter with a fine tooth comb".

19          d.     Respondent stated she is "done with this" and terminated the phone call  
20          before Board staff could respond.

21          7.     Board staff presented Respondent the opportunity to participate in an  
22          investigative interview during multiple dates and times.

23          8.     Respondent indicated she was not available during any of the offered dates or  
24          times.

25          9.     As a result, Board staff sent Respondent a subpoena to appear.
